LifeLiner - Major Overhaul

Last week, I received a very nice thank you letter from the ISO regarding my total contributions to Gamblers Anonymous under the LifeLiner program for 2015. I looked at the number and I thought that the amount was just not a lot of money, relative to what I could have contributed. Therein lies the problem, at least for me. My hope is that what I write here, gains a lot of traction with everyone who reads this submission.

I thought about the entire LifeLiner program and how we, as Trustees, Trusted Servants, and GA members, deal with contributions. Personally, I think it is time to revamp things from the top down.

Why is the LifeLiner program kept under such secrecy? I agree that it is inappropriate to let anyone know how much any GA member contributes, but why can't we list out the names of those who are LifeLiners? This should be done on a state-by-state basis. Why don't we start with the Board of Trustees? Let's see how that goes and then work it into the members at later time.

I looked at the back of our LifeLiner Bulletin, and if ever there was a need for a makeover, that page is a prime candidate. I don't know how old that page is, but the information is not a strong enough message to those who are looking at it.

Next is making a more effective approach that needs to be addressed at the Intergroup and room levels. Unfortunately, this is going to be a struggle in our area, same as it is to get members to register to our website, and trying to get members to volunteer for the National Hotline in our area.

Our area has 50 rooms and only 254 registered members to our Intergroup website. You do that math, it's pretty sad. I'll go one step more. We are happy to say that we have our hotline covered with a minimum of 2 volunteers in every hour of every day, throughout the 168 hours of every week. However, that is only for 49 volunteers, again you do the math with 50 rooms.

That brings us up to LifeLiners. We get semi-annual glimpses at LifeLiner data at the Trustee meetings, but only about how much is collected by each state and how many people contributed to those numbers. It's something, but it doesn't do much to add any structure to not just making others aware of LifeLiners, but to get our membership to step up and take what is generally a nominal plunge into

contributions.

Our pressure relief forms account for contributions and LifeLiners are mentioned, but usually, that is not the time to get a commitment from the member having pressure relief. As a result, becoming a LifeLiner always seems to not be a priority in the future.

The Trustee Website Committee hopes to submit a protocol in Phoenix to allow for online contributions directly to ISO. There are security issues and procedures that need to be put into place to ensure that we are getting contributions from GA members and no one else. This may help, but we have to get away from the promises that members make to be LifeLiners and get them onboard to help them follow-thru with those promises. It's a long-range project that we have to start sooner than later.

So in spite of what needs to be a major overhaul of the LifeLiner system, I have a very vivid image in my head of that thank you form that was sent to me, and I will become far more aggressive with getting people to become LifeLiners in the rooms I attend and visit. I hope everyone reading this posting, will also become more proactive in this matter.

How about others putting their experiences with the LifeLlne process into print for everyone else to read?

Reciting The Lord's Prayer

David M. recently posted a question in the Trustee Poll that asked the question: "Reciting 'The Lord's Prayer' or any other prayer that is not part of GA approved literature is not permitted and a violation of the Guidance Code and the Unity Steps."

It intrigues me that as of 2/7/16 the voting on this item is running darn close to 50/50 in favor/not in favor.

Personally I see this as a cut and dried issue. As current and past trustees we all should have at least a passing knowledge of the Guidance Code. Article VII (esp. Sections I and 7) clearly define what Gamblers Anonymous approved literature is and that it is the only literature that can be used in a GA room.

To my way of thinking the use of any prayer not included in the approved literature is a clear violation of the Guidance Code and should not happen under any circumstances. Beyond the Guidance Code aspect it seems to me to be a matter of common courtesy and respect for others. We should be careful about bringing in outside issues such as particular religious teachings that might offend

and/or harm someone else's recovery. The Fellowship of GA is open to all who have a desire to stop gambling no matter their creed.

Judging from the poll results so far I'm sure there is a belief that I am quite wrong on this subject and I'd love to hear your opinions on the subject.

I think the problem of reciting the Lord's Prayer at meetings is part of a much bigger issue, that is, how does one actually go about enforcing the Guidance Code at the meeting level. It is easy enough to say something is, or is not, consistent with the Guidance Code, it is yet another matter to actually address what to do if a meeting is not following one or more aspects of it. For example, I had the privilege of attending a birthday meeting this past Saturday when out of the blue, the chairperson began reading a meditation out of a book written by a famous philosopher that was obviously not part of GA-approved literature. Perhaps he was not conversant in the Guidance Code but just as likely, he was but felt there was nothing wrong with doing it. As a trustee (and the other trustee from my area attended the meeting as well), I could have easily interrupted the meeting and reprimanded the chairperson for not following the Guidance Code but it would have definitely killed the spirit of the birthday and probably incited a riot among the attendees. Therefore, as a followup to the question in the Trustee Poll about reciting the Lord's Prayer at meetings, perhaps we as a fellowship should begin looking at formal step-wise mechanisms within the Guidance Code for actually enforcing the Guidance Code so it is being done on principles rather than the whims of the personalities.

Prayer is a very personal thing, we have many atheist in our rooms who struggle terribly with this issue, I for one will not force it on them. Our literature is based on spiritual principles not RELIGIOUS ideas. If we open the door to one denomination, you have to open it to all. Get ready to start changing some more literature, page 2, Gamblers Anonymous is not allied with any sect, denomination, politics, organization or institution; DOES NOT WISH TO ENGAGE IN ANY CONTROVERSY; NEITHER ENDORSES NOR OPPOSES ANY CAUSE.

The idea of a Higher Power is an individual decision, not a group decision. Y'all are walking a very thin line, the Serenity Prayer was accepted because it is universal and non-denominational, it just happens to be the one all recovery programs accepted. 39 Meetings A Year

Article VII, Section 4 of the Guidance Code states, "Abstinence from gambling and regular attendance of at least thirty-nine (39) Gamblers Anonymous meetings (exceptions can be made, via group conscience decisions, for medical reasons, and military stationed overseas) in the prior 12 months, by the member's own admission, is required for pinnings and all successive anniversaries. Date of abstinence starts from your first meeting after your last bet."

With the exception of the last sentence from Article VII, Section 4, I'm wondering if we still need the above language from the Guidance Code. While there have been no issues that I am aware of in my area as to anyone celebrating an anniversary by not meeting the 39 meeting requirement, I'm sure it occurs elsewhere. If it does, or if there is any question, do room secretaries ask if a member has the necessary meeting requirements? If not, is anything done? Or is there any question as to a member's answer? Also, how do others feel about this requirement? Do any trustees look the other way, or not want to enforce this provision of the Guidance Code? I ask for answers to these questions, as well as thoughts on whether or not we still need this provision. I'll give my thoughts on the need for this below. I also ask for any disagreements, or agreements, on what I say.

My thought is we should do away with this part of the Guidance Code. I feel that way because maybe this is one thing we can give back to rooms to decide who celebrates an anniversary, per their own group conscience. I, for one, wouldn't want someone who hasn't been attending any GA meetings to celebrate. But it wouldn't be just my decision, it would be my homegroup who would decide. After all, the only requirement for Gamblers Anonymous membership is a desire to stop gambling. I think I read that somewhere. So why not allow each room decide who is worthy of celebrating an anniversary. After all, we don't take someone's time away if they don't attend meetings.

I look forward to any response, either in favor of eliminating this section, or not.

Pete, you bring up a great point. I am in favor of your position although not for the same reasons. Even though this is supposed to be a program of rugged honesty, there is really no way to even verify if a member has attended 39 meetings. I supposedly if you attend the same meeting each and every week, there is a record of it, but if you attend different meetings like I do, nobody at whatever you call your "home group" can really say whether the 39 meeting requirement was met or not. And then there is the question of what constitutes attending a meeting. I was always taught that a meeting consists of a call to order at the beginning and the Serenity Prayer at the end, yet how many times does someone walk in 10 minutes before the meeting is over, apologize for being late, and still end up in the "book" as having attended? To my way of thinking, if there is no way of independently verifying that the person attended 39 meetings and there is no working definition of what constitutes a "meeting", why, indeed, leave it in the Guidance Code as a specific requirement for anniversaries/birthdays/whatever.
