Dear Sisters and Brothers...

As I mentioned in my last Trustee Line submission that I would contact the Cherry Hill Hotel regarding the 72-hour cancellation clause John B from Area 13 raised concerns about, and our representative responded with this email after we spoke this morning...

- A reservation may be cancelled without penalty up until 3 days/72 hours prior to arrival; thereafter, the individual guest would be subject to a one night's room & tax penalty.
- A reservation arrival and/or departure date may be adjusted at any time, and subject to availability of guestrooms if extended the stay
- If a guest requires an early departure, we prefer notice by 4:00 PM the day prior to early departure, or at the very latest, the guest must vacate the room before 11:00 AM on the early departure day and notify the front desk of the early departure at that time. No penalties to apply for early departure within these guidelines.

What this means is if we conclude on the second day (Tuesday) you will have until 11:00 on Wednesday to cancel the third night with no penalty of payment...

I hope this clears up confusion and concern about being on the hook for a third night if we only go two days...With that in mind we ask that you begin booking rooms as soon as possible so we start to get a feel for how many Trustees will be attending...
