At a recent Intergroup meeting a member requested permission to put up a poster from the Nevada Council on Problem Gambling that announced March as Problem Gambling Awareness month. The chair of Intergroup asked me for my opinion on this. I said that my understanding was that only GA approved material was allowed to be posted in the room. Based on that the chair denied the member permission to put up the poster. The member desiring to put up the poster was visibly upset and called the decision "crazy". While I empathize with that member I believe that my statement was correct and in conformance with the guidance code. Could there be something I have missed that might have allowed the posting of this piece? It seems that even though it is not a

GA approved piece, might it not be appropriate and therefor allowable?

Article VII, Section 8:

"Gamblers Anonymous appropriate literature is limited to local area member telephone lists, meeting and direction lists, flyers regarding events sponsored by the local rooms(s), Intergroup(s), surrounding area(s) or conference committees. Other appropriate material must be designated as such by the Board of Trustees."

What part of Article VII, Section 8 is confusing?

In my opinion, when the member asked about hanging up a Council poster, he should have been handed the Guidance Code. When the chair of the intergroup asked the Trustee for his opinion, the chair should have been handed the Guidance Code. Personally, I think it's a shame that most members aren't familiar with what our Guidance Code states, and/or just don't care; but that's the way it is. However, when a member chooses to become an Intergroup Rep, Group Secretary, or officer or Chair of Intergroup, and still doesn't study the Guidance Code, it borders on disgrace. Gamblers Anonymous has very few rules, but the ones that exist are important and, as in Article VII, Section 8, usually very specific. Also, hanging a poster from ANY outside organization would definitely be seen as us endorsing that entity, a clear violation of Unity Steps 6 and 10.

Suggestion: A short time ago, Delaware Valley Intergroup (Area 13) purchased enough copies of the Guidance Code to provide all of our groups with one. The object of the exercise is to ensure that all members, especially the group secretaries, become familiar with the material. (Now, if only we could ensure that the material will be read.) My opinion: You didn't miss a thing, Terry. Its absolutely NOT allowable. (No wiggle room)
