Last month, I tried to light a fire under the otherwise sleeping group of 127 current Trustees, by throwing out some subjects that might have gotten others to speak their minds. One thing is clear, my objective was a virtual failure. So I will try once again with this topic.

We are very close to the launch of a mobile app for locating meetings in the US. Although it is still in test phase, it was released for inspection of the Trustees for the Spring Trustee meeting in Phoenix this past May. If any of the Trustees had an Android phone, they got the opportunity to test the app. As the saying goes... "Be careful what you wish for."

Interestingly enough, there were many downloads done by the Trustees and that's when the problems started. The Trustees started using the app and many found that rooms were listed that have been closed. There were others that had time changes and the information had not be changed on the site.

The problem is that this meeting locator app works off the database kept by the ISO. Another saying is... "Garbage in – garbage out." That is the crux of this posting. The ISO can only work with the information it gets. If meetings close or change their times and that information is not reflected to the ISO, then the ISO website is not updated. That also means this new pending app will be providing incorrect information to those who need it the most – the new members. This is a clear focus on Question 18.

So a serious problem has been identified and we currently are in dire need of a serious and immediate remedy. Who has the responsibility to keep the information flow correct for the ISO? Is it the trusted servants of the rooms? Is it the local area Intergroups? Is it the Trustees?

I will be submitting an agenda item for San Diego, to hopefully have the BOT Chair form a committee to deal with this issue. It has to become a priority for the Board of Trustees. Time and time again, I hear from some of the members of our Fellowship that the BOT does little if anything to carry the message. I take offense at such statements from people who have no remedies or ideas for carrying the message. However, for whatever we offer those who have a desire to stop gambling, we can't actively sabotage those people by sending them to rooms that have closed or changed their meeting times.

It's time for the very thing that the 'complainers' try to convince others that we don't need – structure. This committee would have to come up with the procedures to ensure that meeting information is as correct and up to date as it can be. It would be great for those who read this posting to come up with some ideas on how to do this, or for you to further highlight how severe this problems really is.

Two heads are better than one, five are better than two, etc. Let's make it happen.

From January to June 2016 there were 25 topics posted to the Trustee Line that stimulated a total of 34 responses, 1.36 average responses for each topic.
