I see nowhere that it says a member cannot celebrate an anniversary. I am all for celebrating with a member on their anniversary, even if they only come to 10 meetings a year. I am NOT for giving that member a coin or pin.

Maybe it's just me, but the coin/pin signify more than just abstinence, it also shows involvement and dedication to the program. I do not see where this conflicts with the Unity Program, but I do see where this will build consistency in a group and consistency will help unity.
