I Can't Believe He Just Said That

I had a very disturbing evening last night. I ended up meeting another GA brother for a quick dinner before going to a meeting I seldom attend. Although I didn't know it at the time, that was going to be the best part of my night. As the meeting started, in walked a member with a few more years in the program than I have, and my heart immediately sank. I had not heard his therapy for many years and my sincerest wish was that he not spew the venom of discrediting the GA program that I remember from my last encounter with him.

Sadly, his therapy was more vicious of the program than I remember. I had to close my eyes and was wincing in pain over the negative words about the program that just seem to intensify as he continued. I am not going to go into therapy, but here are the bullet points of what unnerved me.

The program is a joke The steps are worthless Pressure relief doesn't work Bankruptcy is fine People should not give any advice The 800-GAMBLER number is the GA hotline And other such pearls of 'GA wisdom'.

Strangely enough, his stories about the detrimental effects of gambling are clear and very supportive of why people should stop, but that's where it ends. This room had a limit of 2 comments per therapy. I waited to hear the first comment to see if someone whose home room that was, would clear the air, but it turned into something similar to "It's good to see you and I don't agree with what you said, but keep coming." I raised my hand, but the second and final comment was given to someone else. It too was a softball and was punctuated by saying "Well at least you are talking about how you feel." I was called on next to give therapy and did not give him a comment, as we in NJ do not allow members to do that. Here's the point of this posting. I felt immobilized that I couldn't actually stop his therapy, because the room had numerous members under 6 months who were struggling with their recovery. One person like this can provide all the reasons why they should take back their wills and ignore Recovery Step 3. I am reminded of the first paragraph on page 2 of the Combo Book.

"Gamblers Anonymous is a Fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from a gambling problem."

This man and his pernicious words about the very essence of the Gamblers Anonymous program are detrimental to Gamblers Anonymous as a whole. New members struggle for many reasons. Therapies and comments are supposed to be constructive in the learning process. People who struggle and speak to the difficulties and frustrations they face in the program are a necessary part of bolstering all of our recoveries. Comments are the helping hand of others who have walked in their shoes. We cannot allow members to send very direct messages that sabotage the very reason we exist and the efforts we extend to carrying the message of hope. The question is how.

Obviously, there is nothing in any of our literature that helps a room deal with this type of member. Numerous rooms will just not comment on this person's therapy and explain how damaging it is. He hides behind his justification for saying these things by adding in that "At least he is telling the truth about how he feels." I know that people have spoken to him about this poisonous attitude and have told him that if he doesn't believe in the program's core principles, then stop coming to GA and making it unbearable for others. Nothing seems to have gotten through to this guy. It's truly like talking to a wall. Group conscience meetings have tried to get rid of him, but Unity Step 5 is always the bedrock reason for the rooms not banning him from the meeting(s) he attends.

I'm looking for some answers from those current and past Trustees on how to remove this cancerous situation from all the well-intentioned efforts of everyone else who is working the program. Please do not tell me to give it up to my higher power. I also don't want to hear that I should ignore it and just worry about myself. That is not going to do anything to change the detrimental issues this person brings into the meetings. I am a Trustee looking to follow the Responsibilities For International Trustees.

This issue may be I of the single most difficult to deal with in Gamblers Anonymous. I was recently elected to be Secretary in my home group again. I have discussions with people all the time regarding what is and isn't appropriate therapy aside from if you believe it isn't, what should the response be?

Although not necessarily "best case", when Secretary I employ the following:

Try my absolute best not to be too quick to interrupt someone's therapy. Giving therapy is where it all begins and on a certain level I'd rather be a moment late than too fast. None of this means, if a person is given latitude and abuses it that I won't step in explain why I stopped the person and welcome them to continue in another direction. If something was inappropriately touched on and the person moved on, I would make a general announcement to the individual if in fact they said something inappropriate.

If I am not the Secretary and a boundary was crossed, I would most certainly try to make a comment (if they are allowed) to cover the same ground.

Lastly, if I am not able to do either of the above I would most certainly bring the matter up in Good And Welfare. I am not sure all areas have it but in NY, it provides an opportunity at the end of the meeting to voice concerns.

Make no mistake in situations that are chronic, the Officers and Members of the room need to be diligent otherwise the fabric of GA will continue to be eroded.
