

We Need Feedback From The Trustees

12/11/16 - 4:03 PM Greetings trustees,

At the latest trustee meeting held in San Diego in October 2016, the Conference Oversight & Assistance committee presented an item proposing to replace the "Hosting a International Conference" pamphlet with a new version.

This new version was to include most of what is already in the present version, adding some new features and the documentation prepared by the first Conference committee, which documentation has been approved as appropriate literature and is displayed on the trustee website, under our committee's heading. Some of the added features would be a Table of Contents, a Generic Registration Form and other documentation.

A motion was made to approve as is and a discussion followed. After a number of negative comments, a Motion to Commit was made and approved, which sends the item back to the committee so that the item may be put into better condition for consideration by the Board of Trustees.

After the trustee meeting session, I spoke with a few of the trustees who had expressed their concerns about the revamped pamphlet and asked them to send their thoughts and suggestions to the committee, in order to help present a better version at a future BOT meeting. Unfortunately, the Conference Oversight & Assistance committee has not received anything, despite the discussions I had in San Diego.

The Committee still believe that this improved piece of literature would help to a greater extent any Area wanting to bid for an International Conference, as well as an Area which has been granted the privilege to host such a conference. We urge trustees to send us an email expressing their concerns or suggestions, so we can take those into consideration before presenting another motion in Cherry Hill.
