Trustee Line Note: This was a topic presented in November with new comments in December.

Hello Brothers and Sisters,

I didn't think I would ever be a Trustee again, but I make plans and G-d laughs. I'm honored and privileged.

In the past I was I proponent of changing the Steps similarly to their original form as Alcoholic Anonymous wrote them. I usually put one or two on the agenda. One time I got close to 50% on one item, but far from two thirds.

I speak to members in my Area, and many would like to see the Steps changed to reflect their original intentions. And if you know me, and like talking Program, this subject often comes up and I get a lot of positive feedback.

I'm hoping this receives plenty of feedback. I worked with David M to get the Trustee Line approved for the purpose of saving time at the Trustee Meeting - by working things out beforehand.

The changes I'm talking about are as follows:

Change Recovery Step 2: Came to believe that a power greater than ourselves can restore us to sanity.

Change Recovery Step 5: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

Change Recovery Step 6: We're entirely ready to have God remove all these defects of character. Change Recovery Step 12: Having had a spiritual awakening as the result of these Steps, we tried to carry this message to compulsive gamblers, and to practice these principles in all our affairs. Change Unity Step 2: For our group purpose there is but one ultimate authority — a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

Note: Higher Power, or God as we Understand Him can be substituted for God. Note: We don't have to change them all.

I'm hoping that if you're not sure about this – Please investigate and read the AA Big Book and the 12&12. They contain the original instructions for 24 Steps that have changed myself and the worldwide recovery community!

Trustee Line Submission: Marc L's Step Changes

I am not advocating one way or the other on these changes, just offering my thoughts. I don't have a vote.

Some thoughts on Recovery Step 2:

The word "sanity" seems to be a stumbling point for many.

It was explained to me many years ago that the restoration to "sanity" does not mean that we are or were insane. It addresses the insane way of thinking and acting when we are gambling. The acts are irrational because they are self-destructive, or insane.

I was told, after being abstinent form my addiction for a period of time, and knowing that my life is starting to improve, that making the decision to place the first bet of what will be a series of bets, is an act if irrational behavior. Abstinent, to place the first bet, that can eventually kill me, just does not make sense. These thoughts are irrational, self-destructive, or insane. GA steps in and stops the compulsion to place the first bet. The compulsion leaves, and I am starting to live rationally, or sanely again.

Does "a normal way of thinking and living" equal "sanity"?

Some thoughts on Recovery Step 12:

There is a reason that this step comes after the previous 11 Steps.

The proposed version speaks directly of the results of an action. Using the definition if spiritual on page 1 of the Combo Book, these are the attributes that one may achieve as a result of working these steps, therefore possibly being better able to carry the message to other compulsive gamblers than one was before. Working being the operative word. I'm not saying that one cannot carry the message without working the steps. Just airing some thoughts. The current version 'Having made an effort to practice these principals in all our affairs' seems to me that an effort to practice, does not imply that one has attempted to work the previous steps, with a sponsor, as the GA literature suggests. Action and results, versus "I tried". I know some will not agree with me. I'm only offering my thoughts
